At its October 15-18, 1997, meeting in Washington, DC, the Unit Accreditation Board of the National Council for Accreditation of Teacher Education (NCATE) considered the application for continuing accreditation of the School of Education at Indiana University at Bloomington/Indianapolis at the initial teacher preparation and advanced levels. I am pleased to inform you of the Unit Accreditation Board's decision to continue the accreditation of the School of Education at Indiana University at Bloomington/Indianapolis at the initial teacher preparation and advanced levels. Details of these actions are provided in the enclosed accreditation action report. Strengths noted in the Board of Examiners report have not been reiterated in the accreditation action report, but are certainly considered part of the institution's accreditation visit record. You may use the information provided in the Board of Examiners report at your discretion.

Let me take this opportunity to congratulate you and your professional education unit for displaying the high quality necessary to be granted national accreditation, and to express appreciation for the cooperation received from the faculty, staff, and administration of your institution.

The next NCATE visit is scheduled for fall 2002, and you will begin to receive materials for that visit approximately two years prior to the visit. (In partnership states, the date of the visit will be determined jointly by the state and NCATE.) In addition, your institution will be required to complete a Joint Data Collection Instrument each year during the accreditation period. This annual report will request current data about the institution and progress made toward correcting any deficiency cited as a weakness in the accreditation action report. You are also expected to report evaluations and improvements made in relation to all standards over the upcoming five-year period.

To assist you in letting potential students and the public know the benefits of attending a professionally accredited school, college, or department of education, we have also enclosed press tips, as well as a sample press release and sample op-eds. Please feel free to contact NCATE's communications department if you need further assistance.

I.A Conceptual Framework

The evaluation design of the model has not been fully articulated.

I.D Professional and Pedagogical Studies for Initial Teacher Preparation

Candidates in secondary education programs are not adequately prepared to teach exceptional populations in the classrooms.

CATEGORY III: FACULTY IN PROFESSIONAL EDUCATION

III.D Professional Development of Faculty

At the Bloomington campus, there is no systematic faculty development plan for cooperating teachers.

CATEGORY IV: THE UNIT FOR PROFESSIONAL EDUCATION

IV.A Governance and Accountability

The governance structure does not ensure that the offerings provided at the Columbus campus of Indiana University/Purdue University at Indianapolis (IUPUI) are consistent with the conceptual framework and performance assessment of the IUPUI campus.

NOTE: All weaknesses reported above must be addressed in the AACTE/NCATE Joint Annual Data Instrument each year during the accreditation term.
