

PERMISSION TO PUBLISH MATERIALS FROM THE LILLY LIBRARY

Statement of Policy on Rights and Permissions

Permission to publish materials from the collections of the Lilly Library may be requested by making written application to the Rights and Permissions Department, The Lilly Library, Indiana University, using the form on the reverse side of this page.

There is no fee for the use of quotations or for citing materials from the collection. The Application for Permission to Publish must still be completed.

It is the policy of the Lilly Library to charge a fee for the publication of each *original and/or rare* item from its collections. Publication fees are separate from all photoduplication costs and are payable prior to publication. Fees for the publication of a large number of items may be negotiated.

We must caution you that the Lilly Library does not own reproduction rights to the material in its collections, except in certain instances. Reproduction for publication purposes, therefore, is subject to your securing permission from persons, corporations, or other legal entities which may own or claim such rights under the copyright law. Under the law effective January 1, 1978, both published and unpublished works are protected by the copyright law. In addition to written works, the law also covers musical compositions, drama, pantomimes, choreography, pictures, graphics, sculpture, sound recordings, motion pictures, and other audiovisual creations. All responsibility for questions of copyright that may arise in the use made of copies of our material must be assumed by the applicant. All requests for permission to publish copyrighted material must be accompanied by a letter of permission from the copyright owner.

The following credit line is required if material from the Lilly Library's collections is published: **Courtesy, The Lilly Library, Indiana University, Bloomington, Indiana.**

In requesting permission to publish a copy of the item or items described on the reverse side of this page, the undersigned agrees to indemnify and hold harmless the Lilly Library from any action relating to infringement of the rights of any person or entity who may claim legal rights in these item or items under common law or under statutory copyright. These persons or entities may include, but are not limited to, authors, editors, contributors, designers, illustrators, photographers, photographic subjects, artists, printers, publishers, and binders, or their heirs, successors, and assigns.
