## Law-Related Volunteer Opportunities

### **Legal Services Organization of Indiana:**

Call (812) 339-7668. Most volunteer positions are related to the process of taking initial client applications. Volunteers gather basic background, statistical, and financial eligibility information. But most importantly, the volunteer listens to the person's problem and prepares a written summary for a staff attorney to review. Student volunteers can integrate course work with the realities of social problems as they explore potential careers, and may qualify as an academic internship.
